

## **Graeme Parker's UK Mental Health Review – December 2024**

This presentation prepared for attention of Lyn Robinson of PRISM who had a face to face meeting with me during October 2022 at Priory Fields Surgery, Huntingdon as I seek a consultant psychiatrist to review my mental health. Strongly believing that in 2012 following deportation from Brazil I was incorrectly diagnosed as being of '*Schizotypal Personality Disorder with Delusional Belief System*'.

Living under a false diagnosis of mental health I believe is inhibiting progress in the following:-

- Acknowledgement by the professional medical community of a muscle paralysis disease caused by water born parasite.
- The Ministry of Defence awarding an Engineering Contract.
- My qualifying for a Private Pilot License.
- Successful prosecution of three Brazilian Nationals.

And delivered in printed format to Priory Fields Surgery Huntingdon on the 19<sup>th</sup> December 2024, as I attend an annual medical.

## 1. Overview

Following receipt of my mental health records and having had preliminary telephone conversation on the 22nd February 2022 with Mental Health Nurse Sue, a face to face appointment on the 23<sup>rd</sup> June with Dr Smith of Priory Fields Surgery and a face to face appointment with Mental Health Worker Lyn Robinson I have been requesting that my diagnosis provided twelve years ago, while being a voluntary patient at the Cavell Centre Peterborough, be changed from '**Schizotypal Personality Disorder with Delusional Belief System**' to that of a '**Post-Traumatic Stress Disorder**'.

This diagnosis made at the Cavell Centre, Peterborough following deportation from Brazil March 2012 after four Brazilians had accompanied me on a flight to London - they being a Federal Police Chief and his wife, a second Federal Police Officer and a Prison Psychiatrist who all took a holiday in a Pimlico hotel. Expecting to be met by my father James Ronald Parker he had passed by Heathrow airport earlier in the day leaving me a bag of clothes, £30 and message with airport social services that I was not welcome in the family home. Chef Delegado Christiano Bath having instigated my abduction and incarceration in Colonia Santana psychiatric hospital, State of Santa Catarina with false statements he going on to corrupt psychiatrists to provide false diagnosis of mental health, reward being a holiday in London. Christiano Bath's actions commencing on the 22nd September 2010 as I attended pre-arranged appointment at his office with intention to update a statement made at the same Federal Police office 19 months earlier at request of the British Foreign Office. My second presentation raising the issue of Brazilian Law's pertaining to national security as I developed media projects dramatizing a series of archaeological discoveries that had commenced during 2006 on Ilha da Santa Catarina, latitude 27deg south Brazil.

Archaeological expedition and supporting studios project funded by a gold HSBC credit card August 2005, consequence of my experiencing onset of a muscle paralysis disease and having prior knowledge of Celtic sacred cartography dividing inhabited islands into four quadrants the central point being site of royal tombs and sun worship temples.

During my stay as a voluntary patient to Consultant Dr Bala in the Cavell Centre, Peterborough 2012, Dr Bala declined presentation of archaeological discoveries and their proposed dramatization projects. Dr Bala passing judgement of my mental health without baring witness to my actions his diagnosis being influenced by 'Brazilian Incidents' and presence of my father.

Expanded reasons for the review being the following:-

- Advancement in understanding a parasitic muscle paralysis disease, an infection that I have been combating since experiencing rupture of left side vas deferens – semen entering bloodstream October 2004 - previous presentation to consultant neurologist being dismissed as '*fictitious hallucinogenic experience*'.
- Deterioration of brain injury – MIR scan of 21/10/2023 revealing volume loss to front brain lobes with prominent frontal bilateral CSF (Cerebrospinal fluid) space confirming that of CT report obtained on my return to the UK from Brazil March 2012
- Brain injury inflicted following abduction on the 22<sup>nd</sup> September 2010 by Brazilian Federal Police and subsequent incarceration in a secure psychiatric ward of policy being all 'patients' to be medicated, my politely and calmly refusing medication resulting in experimental dosage of an anti-psychotic causing long term damage to brain, eyesight and digestion.
- Presentation of Nazi Party diary of year 1938 (year of my father's conception) to UK Police/ Home Office as on the inside rear cover are a list of names that I believe assisted my father procure teenage prostitution in the Fatherland and acknowledgement by Cambridgeshire Mental Health and the Home Office that James Ronald Parker's relationship towards his youngest son Graeme James Parker having been that of a **Sociopath/ Pathological Liar with Paedophile Tendencies**.
- Presentation of Brazilian archaeological discoveries to British Armed Forces co-ordinating with Brazilian equivalent(s) intention being to mount an expedition party.

## **The Last Twelve Year Summary (following deportation from Brazil, March 2012)**

I have maintained a presence in my hometown of Huntingdon, primarily due to concern for a parasitic muscle paralysis disease that I believe to be an environmental issue and to retain continuity with local health services. Since returning to British society I have performed with Huntingdon Drama Club, continued study of music and tested my athleticism in Surfing, Skateboarding and Tennis.

I have become a part of the surf scenes of Newquay and Lanzarote and five years ago dug a vegetable garden in Ilha Margharita, having come close to marriage to a Venezuelan lady.

Since the lockdowns much time has been spent in compiling a portfolio of promotional music videos and a body of knowledge presented as '*Establishing The Los Angeles Embassy To Significant Religious Objects (SRO)*', available at <https://apollobath.org/page5.html>.

Since June 2019 I have mainly resided in a small motorhome parked in Huntingdon and receive Universal Credit.

Returning to surf training summer 2022 and participating in a big wave session at Scarborough September 2022, I experienced near conscious blackout as brain injury had deteriorated two years earlier following consumption of butter. My brain is experiencing a disproportionate shrinkage to both sides of frontal lobes. The greater shrinkage is to the left hand side thus inducing a torsional load felt through the ear that becomes hazardous under full physical exertion.

### **Background Summary**

My mother and father came to reside in Cambridgeshire during 1973, my father James Ronald Parker as an RAF Flight Lieutenant Officer being stationed at RAF Wyton and Brampton, he leaving the Royal Air Force in 1977, my mother Wendy Mary Parker eldest daughter to a Lieutenant Colonel of the British Army Royal Engineers Regiment spent 25 years employed at Hinchingsbrooke Hospital. My parents met in Germany while my father served in the Royal Tank Regiment prior to transferring over to the RAF.

Currently aged 55 I grew up in Brampton Village, attended Hinchingsbrooke School and went on to study Mechanical Engineering at Leeds University and an MSc in Engineering Design from Napier University, Edinburgh (curriculum vitae provided). I have an elder brother named Ian Parker who followed our father's career in aerial reconnaissance and is employed by NATO at RAF Molesworth.

In 1998 my maternal grandfather was sick with bowel cancer and I was living in London dejected with a career in the UK as an Engineer, so I quit my employment and set off for Australia to meet my grandfather's brother and catch up with a former Australian product designing colleague, as I was then nurturing the business plan of communicating engineering projects internationally using the then 'new internet'. Travelling to Australia via Los Angeles, a chance encounter with a Brazilian lady in Santa Monica Nightclub 'The Castle' resulted in this business ambition being applied to Brazil. Sale of my Wandsworth apartment providing £36,000 start-up capital and Centauri Design Ltd was born with my parent's home in Brampton providing registered office address and my retired father James Ronald Parker took on role of company security as I made contacts in Sao Paulo's buoyant manufacturing industry through finding employment within their Aerospace Industry. My employment with Hamilton Sundstrand was terminated following the September 11<sup>th</sup> attacks to the World Trade Centre, New York 2001, by then I had developed in my spare time with a Sao Paulo programmer Product Data Management (PDM) software CAD-Collaborate TM this product at a test and preliminary marketing phase.

In September 2000 my mother had begun to experience onset of a muscle paralysis disease which eventually caused her death in December 2002. I spent the summer of 2002 in my parents Brampton home to be with my mother while continuing to develop CAD-Collaborate. Having lost Brazilian aerospace employment but with substantial savings I took up the sport of surfing, a sport I had always been drawn towards but became a late initiate of at the age of 32 and coinciding with my mother's death I relocated to Ilha Santa Catarina in the south of Brazil – a hot spot for professional surfing talent. Burglary soon alleviated me of computer hardware

and I was left with a surfboard, guitar and car. My mother's cause of death affecting me greatly, intensive surf training followed as I lost about 15kg in weight and I became assimilated into the local professional surf scene.

I returned to the UK in September 2003 with new found athleticism and four surfboards that I had had an input into design and manufacture of as I marketed CAD-Collaborate within the surfing industry. During this trip to the UK, which would be my last until deportation nine years later, I attended a birthday party in London, a university friend's wedding in Kent and competed in British Surfing Championships at Newquay and Tyneside. However on returning to Brazil to spectate in the World Surfing Championships being held at my 'local break' an email from brother informed me that our father had reported me to the UK Police as a missing person. Reading statements made by my father to the Cavell Mental Health underlines my suspicion that the actions of Chef Delegado Christiano Bath were influenced by my father making claims that I was involved in 'illicit drugs' which may have been conveyed by the British Foreign Office to Brazilian Federal Police February 2009.

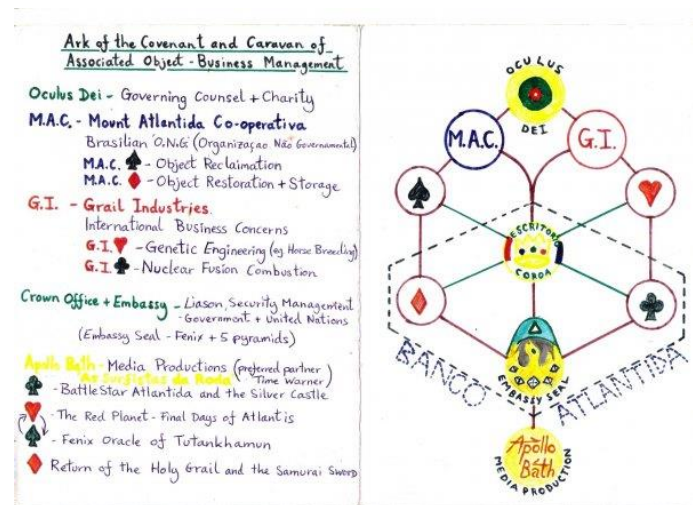

## 2. UK Assessment of Mental Health and Father Son Relationship

On arrival at Heathrow 8<sup>th</sup> March 2012 I am met by airport Social Services informing me that my father James Ronald Parker had passed by the airport earlier in the day and had left me a bag of clothes, £30 and that I am not welcome in the family home.

Discussing my predicament with airport Social Services we decide the best option is for me to seek psychiatric assessment – reason being my attempts to update a statement of my 'Brazilian Activities' to British Government had been denied following abduction by Brazilian Federal Police Sept 22<sup>nd</sup> 2010. Initial Statement having been provided to Brazilian Federal Police at request of the British Foreign Office - March 2009.

Provided with an introductory letter from Airport Social Services I was taken by taxi to Hillingdon Hospital and spent the night there. During questioning by two young house officers the conversation digresses to the subject of introducing the Ark of the Covenant to modern world. I then provide a sketch of the Kabbalah Tree of Life which I had adapted to departmentalize the industries Ark Crown provides – this can now be studied at [www.apollobath.org](http://www.apollobath.org).

One of the house officers was an Irishman whose eyes became tearful, the other a young lady not long out of medical school became sour faced. I was disappointed to learn that she then made comment of my assessment '*...presented with manic symptoms – fleet of ideations*'.

Later in the day I am provided with a mental health advocate who is present during a meeting with a consultant psychologist whose most pertinent question is:- '*During all this time was anyone ever sent to spy on you?*'. I shook my head but think I should have spoken about hotel worker Milton who I believe was a policeman. Held under section 2 of the mental health act I am then transported to the Cavell Centre in Peterborough and become a patient of Dr Bala.

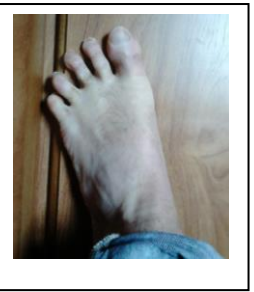
During assessment at the Cavell Centre one psychologist, a young eccentrically attired recent Polish immigrant, attempts to assess relationship with my father – who is making an overbearing attendance during my stay as a voluntary patient – I reply with wisdom provided by the Irishman Oscar Wilde '*We begin by loving our parents, unfortunately we often end by judging them*', and I refuse to make any judgement of my father.

Several times I offer to make presentation to consultant Dr Bala of archaeological discoveries and subsequent artworks but this is declined and on release back into community I am diagnosed as '**Schizotypal personality disorder with delusional belief system...**'. – Dr Bala passing judgement without bearing witness to my actions.

My father died on New Year's day 2016 and I request that Cambridgeshire Mental Health now open their eyes to the discoveries made and take note of the following statements as to father son relationship and change my diagnosis to '**Post Traumatic Stress Disorder**'.

## I recall my father inflicting the following assaults in early childhood.

- Attempted straightening of deformed at birth toes with his clenched fists.
- Nose fracture, my face being slammed into the floor – the first time I 'Ran to Daddy'.
- Smashing of glass topped coffee table as I crawled onto it.
- Chasing around the house and striking with leather bound Military Cane.
- Beatings after every parent-teacher evening
- Beatings in car for him feeling my knees through the back of his car seat.



I have in possession the military cane that my father received through serving his national service with the Royal Tank Regiment and wish to present this to a consultant psychologist/ psychiatrist.



Two examples of the canes use against me are:-

- During the 1970's my father purchased crates of Carlsberg Special Brew bottles from RAF Brampton's Officers Mess and they were stored in the garage. A keen skateboarder I would line up my father's empty bottles on the pavement outside of our family home and perform slalom skating. One weekend not enough empty beer bottles were available and I used some full ones, unfortunately one got broken and beer spilled on the pavement. Consequence being chased up the stairs with the cane.



My father's Saturday afternoons revolved around betting on televised horse racing and consuming bottles of Carlsberg Special Brew. As a child I was taught from an early age how to pour bottled lager and would receive a sip which soon became a gulp as a reward.

- My brother and I would ride our bikes and park them up against the front side of the house, leaving my bike up against the window resulted in a beating with the cane.



For my fifth birthday in 1975 I received a used Puch Mini Sprint bicycle from my maternal grandfather. Two years later, after my brother received a new bike for his birthday, my father sold my preferred ride for £7.50. When it was up for sale I was keen to spend the money on expanding my Meccano set, I had a book of models to build but was lacking the parts required to build an aircraft carrier. On sale of my bike my father pocketed the cash and I was given my brothers old bike.

On first moving to 41 Layton Crescent, Brampton my father would hide the cane inside his grandfather clock at the foot of the stairs. He later stored it by the front door along with a golfing umbrella, a couple of sturdy walking sticks and a shooting stick (kind of collapsible stool) and I lived in fear of being struck with those items. On first receiving the inherited grandfather clock I vividly recall him giving me the most threatening and menacing glare that made me deeply shudder as he clutched me by the collar while he hid the cane inside the clock case for the first time.

The last two occasions he chased me up the stairs and into my bedroom with his cane I recall becoming numb to the blows and with forearms protecting my face and head vividly remember seeing in my father's eyes a look of 'ecstatic glee'.

## Psychological harm in early childhood

- Teasing as to being a chimpanzee



Saturday morning television provided viewing of Tarzan episodes. My father would point at the screen and say '*Look there's Graeme, there's Graeme!*' as Cheetah the chimp performed for the camera. It made me feel confused and distressed as I thought Cheetah looked ugly.

- Teasing as to having a girlfriend – any mention of friends of the opposite sex resulted in my father saying in a teasing manner – '*Ooooh has Graeme got a girlfriend, has Graeme got a girlfriend*', this made me feel embarrassed and very shy.
- Calling me ballerina boy and in need of a Too-Too (a dress worn by ballerinas).

## Psychological harm in secondary school days

- Denied study of Art – entering second year of comprehensive education, children are forced to drop subjects. Art was my favourite subject and I had excelled at drawing and painting from an early age. I vividly recall my father saying '*He's not studying art*', I cried and even protested to my form teacher but my father's ruling was followed. I then became a bit disruptive and dejected with schooling.

Consequences – Alcohol abuse from age of 14, acute shyness of girls, premature baldness and lack of natural rhythm and timing. As an infant I recall becoming flushed and embarrassed as a teacher performed with a piano.

## Malicious Intent in adulthood

### September 2003

A year after my mother's death I return from Brazil to compete in British Surfing Championships and attend a birthday celebration and a wedding of friends from my days at Leeds University. I imported from Brazil four surfboards of which I had had design input with the shapers, two of which were intended for sale in the UK. At this time I was also marketing software CAD-Collaborate which I had previously designed and had programmed in Sao Paulo while employed in the Brazilian Aerospace Industry.

Travelling by hire car from Newquay, Cornwall to the north of England I pass by the family home and retrieve personal valuables. My father started an argument saying I was too old to be surfing and that I looked skinny.

After competing in Tyneside I fly to Stansted and spend two nights as a guest with a University friend in London. Returning to Brazil after a three week trip, I watch Kelly Slater (two years my junior) win the Brazilian world surf tour event in a final against fellow monkey man Mick Fanning, I then receive an email from my brother informing that our father had reported me as a missing person to the UK police. I believe my father made me a **suspect of international drug trafficking** (Surfboards made of Cocaine!) and the reason why I was later treated as a criminal by Brazilian police.

## Year 2005-2006

Through Surf training I recapitulate the assaults of my early childhood and exit a **34 year period of traumatised shock**, overcoming the fear of surf riding having brought back the memories of my father's violent behaviour towards me as a child. This resulted in regaining natural rhythm and timing – a period of awakening enlightenment as my athletic and sporting ability improved greatly – could even run faster and begin to sense natural rhythms and play the guitar and drums well. Surrounding friends declare that I am 're-born'.

## February 2007

Housed by wealthy hotel owning family DesJardins, who had witnessed my experience onset of a muscle paralysis disease and whose campsite I had initiated archaeological expedition from, invite my father to stay.

My father comes to Brazil but stays a few days in Rio de Janeiro before arriving in Florianopolis, he refuses free accommodation and opts to stay in a hotel downtown next to the red light area.

I confront my father as to childhood assaults and forgive him, as life had taken me to where it was at that moment. He denies everything, accuses me of slander and he behaves like a spoilt squirming little girl!

My mother had died from a muscle paralysis disease in 2002. Three years later the consequence of my experiencing onset of same symptoms was to initiate archaeological expedition of mountainous region central to Ilha Santa Catarina believing that I had about two years left to live.

My father came to Brazil insisting that I return to UK and see the same doctors as my mother, I refused and negotiated that I will fill in the passport application form he had brought with him in exchange that he pay for me to see a consultant neurologist in Florianopolis, he obliged but later referred to this as my attempting to blackmail him.

Witnessing my difficulty to hold a pen for filling in a UK passport application – the air conditioning of his hotel room affecting the paralysis in my hands – my father offers me a Tom & Jerry nail brush as a present. I responded by saying *'You're a fu\*\*ing bastard!'* I leave the hotel room and share a cigarette with a one legged man begging for change at traffic lights, the toxins of cigarettes I had found to quell paralysis growth.

As a child my maternal grandfather was an avid fan of Tom & Jerry cartoons, but he would hold an exaggerated laugh at the violence inflicted by Tom on Jerry.

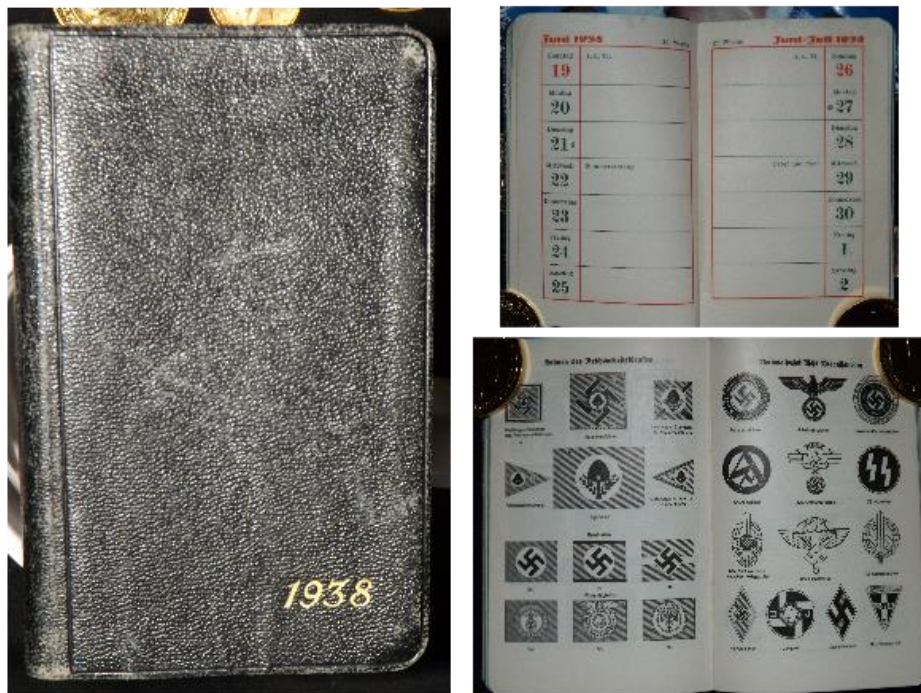
My father a devout white supremacist was politically against my claim as to finding storage location of The Ark of the Covenant, during taxi ride to Brazilian health centre he told me *'It is not unheard of for fathers to bury their sons'*. He then received a visit from an estate agent, my father acting as a property speculator in a meeting I was not invited to.

On his return to England my father wrote a letter stating that my health concerns were a neurosis and that I was a drug addict not in control of my actions. I reacted by sending a letter to childhood neighbour and retired policeman Mr Beckett as I was very close to losing use of both my arms.

## Rest in peace

Provided with presentation of this statement is a Nazi Party diary of 1938 - the year of my father's conception. Following the death of my mother 31<sup>st</sup> November 2002 my father began to make trips to Germany, as a young army officer stationed in the fatherland of the 1960's he would have frequented brothels, the death of his wife taking him back to his previous life. In the inside cover are a list of German names that I believe assisted James Ronald Parker to procure teenage prostitution.



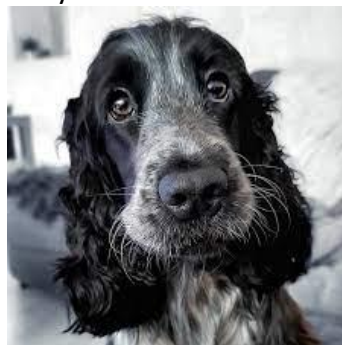


Nazi party diary found in my father's desk

On clearing the family home I found over thirteen small watering cans, which I believe he had used to follow his granddaughter around the garden with as she was growing up.



I also wish it be noted the behaviour of my father towards our pet dog Aimi a blue roan cocker spaniel. As a puppy in 1974 Aimi woke up for her first day in our kitchen at 5 Acheson Road, RAF Brampton. The dog's first interaction with master James Ronald Parker was to being violently struck for having gone to the toilet on the kitchen floor. Aimi spent her short life highly stressed, refused to play ball, pulled hard on her leash and spent her days barking at the back gate to passers-by.



When my mother had paralysed legs she once telephoned me in a distressed state, I believe my father had left her locked in the car inside the garage.

I believe my father in his relationship towards me was that of a **'Sociopath/ Pathological Liar with Paedophile tendencies'**, who on several occasions acted very much against the best interests of my health, safety and well-being.

He had a good sense of humour and I enjoyed his company in the 1970's while watching TV comedy the Goodies and Kenny Everett.

After his funeral his sister Coryn told me *'He had been sick for a very long time'*, the night my father died I learnt from a dream that he had been ritualistically sodomised at the age of nine by his Scots public school masters.

On studying my mental health record I see statements that my father had been saying that I was threatening to kill him with a spade, was using illicit drugs and not well. I confess to being an occasional user of cannabis and discovered that the lowering of metabolism it induces entices growth of parasitic paralysis infection.

Learning to surf in Brazil has been my most enjoyable and rewarding experience of life so far. My mother's death affected me very much and I was surf training the day she died, within a year I had lost over 12 kilos in weight and life had gone from a drunken engineer to that of a professional surfer and am proud to be a part of Brazils *'Geração Saúde – Generation Good Health'*. My father's condescending emails and denial of my being sick with the same paralysis disease as my mother resulted in my sending email *'You disgust me'* and *'Jesus Christ says that you should bury your father'*.

A few months before my father died he said *'I will do all I can to prevent you from returning to Brazil'* and when I commented about his communities television use he replied *'There is nothing else to do.'* For prosperity I wish it be noted that my father was a leading representative of a generation whose real life living had been destroyed by over 40 years of TV addiction.

A few days before he died, Christmas 2015, visiting him in Hinchbrook hospital I turned on the television at the foot of his bed. As the screen came to life it displayed *'Indiana Jones and the Last Crusade'* and a castle scene of Indy, his father Sean Connery and a Nazi officer. My father protested demanding that I *'switch it off, switch it off'* – I disobeyed and changed the channel – the next channel was showing documentary *'Wild Brazil!'* – the final television broadcast his watery green eyes witnessed...

My brother followed our father's career in aerial reconnaissance and is employed at the NATO Intel Fusion Centre, RAF Molesworth.



I believe my brother's attitude towards me was moulded when he was aged seven and I was four. Growing up in a Morris Minor rear seat behind our father I was jealous of Ian as he had first born privilege of travelling behind our mother and the extra leg room provided. A lanky child, on long journeys to our grandparents, as I grew our father disciplined me to sit still as any movement of my knees would result in he stopping the car to give me a beating and threaten to leave me beside the road. Ian would then be awarded the luxury of riding in the front passenger seat as our mother took my position to comfort me as she glared at her husband. This occurred frequently.

Dear Cambridgeshire Police, Government Home Office and Cambridgeshire Mental Health Services

**Ref: Posthumous incident report of Mr James Ronald Parker's misdemeanours that warranted reporting to social services/ police at time of occurrence. Mr J R Parker formerly of Brampton Village Huntingdon deceased 2015.**

It is with great reluctance but belief in necessity for the greater good that I Graeme Parker youngest son to James Ronald Parker am submitting this report. I wish the following behaviour of my Father be known to UK Police, Home Office and Cambridgeshire Mental Health Service.

- **1970** - Fracturing the nose of Graeme Parker by slamming his face into the floor the first time he '*Ran to Daddy*' as a baby, also attempted straightening of deformed at birth toes with his fists. Consequence to his youngest son being a 35 year period of traumatised shock inducing suppression of natural rhythm and timing.
- **1974** – Violently scolding a cocker spaniel puppy on her first morning of residence at 5 Acheson Road RAF Brampton, as she greeted James Ronald Parker's entrance to her kitchen abode – his action a consequence of the puppy having used the kitchen floor as a toilet.
- **2001** – Leaving his disabled wife (Wendy Mary Parker deceased from paralysis disease November 2002) shut in the car parked inside closed garage at family home 41 Layton Crescent Brampton - to her great distress.
- **2003** – Reporting Graeme Parker to UK Police as a missing person and made suspect of international drug trafficking, while knowing full well that his son's actions were that of a travelling competitive surfer marketing engineering software.
- **2007** - Offering Graeme Parker gift of a Tom and Jerry nailbrush while he struggled to hold a pen to fill in a UK passport application form as a paralysis disease affected both his hands. During taxi ride from Brazilian health clinic to his hotel James Ronald Parker stating "*It is not unheard of for father's to bury their sons*". He going on to make written claims that disease concerns were a neurosis and influencing mental health staff that his son was a delusional drug addict threatening to kill him with a spade. Consequence being zero official progress in understanding and curing a life taking paralysis disease that Graeme Parker has been successfully combatting for 16 years.
- **2012** – Following Graeme Parker's deportation from Brazil and being housed at 51 Ashton Gardens Huntingdon James Ronald Parker informed his youngest son as to the 'parties' he had been attending in Germany following the death of his wife in 2002. Graeme Parker forcibly ejecting James Ronald Parker from Ashton Gardens and four years later on while clearing out his deceased father's desk at Brampton unearthed a Nazi Party diary of year 1938 the time of James Ronald Parkers conception. The inside rear cover providing a list of German names and addresses in his father's handwriting that may have assisted in his procurement of teenage prostitution.





Provided on enclosed CD rom is document *'Graeme Parker's UK Mental Health Review – June 2023'* presentation of which commenced last year as I make repeated requests to have my mental health diagnosis of 2012 changed from ***Schizotypal Personality Disorder with Delusional Belief System*** to that of a ***Post-Traumatic Stress Disorder*** and have it recognised that my father (James Ronald Parker's) actions towards me since the first time I *'Ran to Daddy'* were that of a ***'Sociopath/ Pathological Liar with Paedophile Tendencies'***.

I first informed a UK Policeman (retired Mr Peter Beckett childhood neighbour of Brampton) of my father's actions towards me during spring 2007, following my father's visit to Brazil under invitation by my then host Dna Veira DesJardins of Joaquina Beach, Ilha Santa Catarina. The DesJardins family having assisted in my using a gold HSBC credit card in 2005 to initiate a studios project in support of an archaeological expedition. Stargates of the World United'* has been expanded upon providing storyline of Richard Branson.

## Incident 1

### Plaintiff's Abduction and Incarceration Orchestrated by Christiano Bath

**Location – Federal Police Headquarters, Florianopolis, SC, Brazil**

**Tuesday 21<sup>st</sup> September 2010**

At request of plaintiff's host <name un-disclosed> plaintiff makes presentation of damaged passport to a Federal Police Immigration Officer at Florianopolis Federal Police HQ and an appointment is booked for the following morning with Chief Delegado Christiano Bath – who 19 months earlier at request of the British Foreign Office had taken a lengthy statement as to plaintiff's activities in Brazil.

Host <name un-disclosed> wishing that the Federal Police be informed that plaintiff was no longer residing in Joaquina Beach but was once again a guest in his family home of <address un-disclosed>, Estreito, Florianopolis. His mother <name un-disclosed> (recently deceased) having previously provided plaintiff with food and lodgings as plaintiff experienced onset of a limb paralysis disease during 2006 – curing found with medicinal tea.

**Wednesday 22<sup>nd</sup> September 2010**

Arriving on foot at Federal Police HQ for 10am appointment, plaintiff sat outside Christiano Bath's office and is kept waiting for over an hour while a Detective Inspector enquires as to the reason of presentation. Plaintiff informs the Detective of intention to update statement made in March 2009 and with assistance of prepared schematic engineering diagrams explain to the Chef Delegado the scale of archaeological discoveries made and resolve visa issue – passport having expired July 2006.

Archaeological discoveries having expanded from the initial mountain top temple site reported to British Foreign Office during February 2009. Three further locations having now been uncovered.

Entering Christiano Bath's office plaintiff observes the Chief Delegado to be in a 'tearful state'.

Seated opposite Bath at his desk plaintiff presents a copy of '*Codigo Penal 1985*' (a book provided by host <name un-disclosed>) and raises concern as to laws pertaining to the disclosure of '*Military Installations*'. With the aid of prepared drawings plaintiff commences explanation that further archaeological excavation of earth and stone masonry would reveal a site of great antiquity and excavated material would provide '*Defensive Fortification*'.

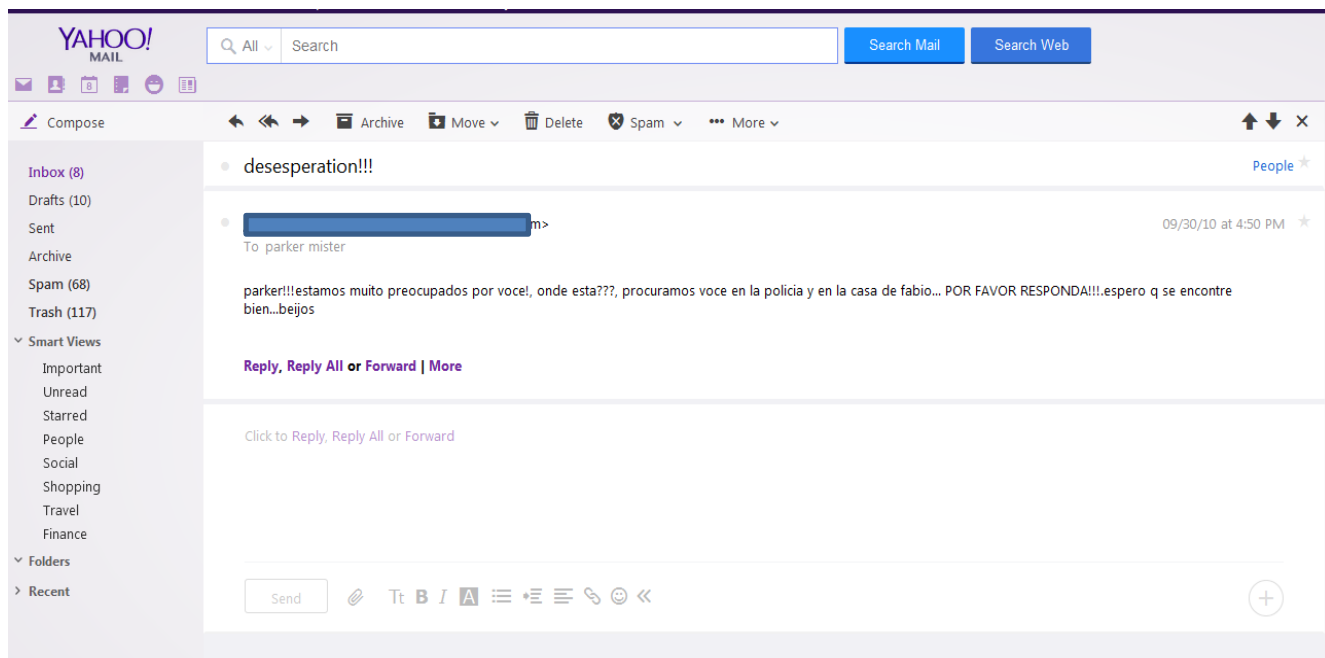
Plaintiff's previous statement informing Federal Police of a '*Studios Project*' commenced in 2005 – it's intention being proposed dramatization of archaeological discoveries. Plaintiff expresses concern that augmenting media projects may infringe a law contained in '*Codigo Penal 1985*' that was punishable with up to 15 years imprisonment.

Chief Delegado Christiano Bath response was the statement '*This law is no longer relevant as it dates back to when Brazil was governed by a military dictatorship*'. Plaintiff questions his denial and emphasize the scale of discoveries made and belief that the foreign military powers of the USA, Russia and China would all very much like the technologies provided by the Ark of the Covenant and Caravan of Treasures.

Bath then abruptly terminates the interview and plaintiff is offered a lift home.

Escorted by the detective waiting outside Bath's office to a pick-up truck in the Police HQ car park, two other officers enter the vehicle and plaintiff is driven to '*Colonia Santana*' a Psychiatric Hospital attached to a Catholic Mission. Chef Delegado Christiano Bath having initiated protocol for deportation with the statement '*Of no fixed residence – Mentally Ill*'. Fixed residence at that time was <address un-disclosed>, Estreito, Florianopolis - abduction by Federal Police resulting in that household's concern of plaintiff's whereabouts.

Below is email sent to plaintiff's Yahoo account on 30-9-2010 from wife of <host un-disclosed> expressing concern, eight days after police abduction following a visit to the Federal Police enquiring as to plaintiff's whereabouts.



Translated from Portuguese the message reads –

**Desperation!!!**

***‘Parker we are very worried about you, where are you? We looked for you at the Police and at Fabio’s house. PLEASE RESPOND!!! Hope that we find you well...kisses’***

## Incident 2

### Dr Ana Claudia prescribing an experimental dosage of an anti-psychotic medicine resulting in Grievous Bodily Harm.

Location – Colonia Santana, Psychiatric Hospital, Santa Catarina, Brazil.



#### Wednesday 22<sup>nd</sup> September 2010

Three Federal Police officers pass plaintiff over to Hospital Security Officers and plaintiff is met by a Dr Fernando who informs plaintiff that he is to be deported to the UK, showing plaintiff the deportation protocol written by Christiano Bath – plaintiff informs Dr Fernando that he has a fixed residence and plaintiff presents to him the same passage from *Código Penal*.

Plaintiff had previously met Psychiatrist Dr Fernando during 2007 following his investigative research into paralysis diseases assisted by the Toxicology department of Florianopolis State University Hospital, where he had become an out-patient to Dr Mario a post graduate student doctor assigned to Toxicology

Dr Fernando now employed at the Colonia Santana witness to confiscation of personal items, they being:

- One tin box containing details of archaeological discoveries and schematic diagrams.
- CD rom of photos.
- Screenplay artwork.
- Passage from *Código Penal* 1985
- King James Bible.
- Medicinal tea 'Flor da Amazonia'
- Clothes and Shoes.

Interned in a crowded secure ward plaintiff is forced to ingest 3 tablets – of compound he is not informed.

#### Thursday 23<sup>rd</sup> September 2010

First assessment by a Dr Ana Claudia plaintiff informs her as to battle against onset of a limb paralysis disease that displayed evidence of a parasitic infection and success with remedy Flor da Amazonia.

Strict ward policy being that all patients are to be medicated, during evening drug dispensing plaintiff is given a small white tablet to ingest. Plaintiff questioning to administering nursing staff as to what the substance is and the intended purpose is given the response '*Are you sleeping OK?*'



Plaintiff pretends to swallow the tablet each evening, but always disposes of it out of a window, fear being that it's a sleeping tablet and will lower metabolism resulting in stimulating resurgence of paralysis disease. Plaintiff's physical state at this time being very good having been able to surf most days and had recovered some muscle mass which had been at it's lowest during 2007 and the time of the severest paralysis attacks.

#### **Friday 24<sup>th</sup> September 2010**

Dr Fernando visits plaintiff in the ward and takes him outside for a chat. Dr Fernando was very surprised to hear that plaintiff had gone to visit the Police. Plaintiff believes the Police had commenced deportation protocol telling the Hospital he had been '*picked up crazy in the street*'.

#### **Thursday 30<sup>th</sup> September 2010**

Routinely exercising every morning in the high walled outside yard, plaintiff uses a red t shirt as a bandana to protect bald head from the hot sun. Not removing this garment to enter Dr Ana Claudia's consultancy room – plaintiff observes she immediately makes a written note. That evening medication is changed to a dosage of anti-psychotic 'Resperidone'

Dosage of one tablet in the morning and one in the evening.

#### **Thursday 7<sup>th</sup> October 2010**

Ward policy being that all patients are to be medicated – during plaintiffs incarceration he observed that the Police use the Psychiatric Ward as a loop hole in their prison system. Interning patients who may be of '*a disagreeable mind-set*' (eg cheeky hip-hop artists or drunken tramps). Colonia Santana annexed to a Catholic Mission the pharmaceutical industry are being provided with a '*Test Facility*'.

Following a week of calmly and politely protesting to Nursing staff, whose job it is to ensure patients take their medication, plaintiff returns the week's dosage of Resperidone in a matchbox to Dr Ana Claudia.

Dr Ana Claudia then asks plaintiff if he had consumed any of the medication since arrival and plaintiff confesses to having consumed only the three unknown tablets on arrival.

Dr Ana Claudia then prescribes a course of 8 large injections of anti-psychotic Haroperidol, the first injection being that evening.

Plaintiff calmly complains to Head Nurse stating that he is being used for experimentation and actions are polemic.

#### **Friday 8<sup>th</sup> October 2010**

Morning injection (the second) bursts a blood vessel deep inside brain and plaintiff struggles to hold the concentration required to deal a pack of cards - evening injection (the third).

#### **Saturday 9<sup>th</sup> October 2010**

Morning injection - administrating Nurse shows clemency and plaintiff is dosed with tablet variant of Haroperidol in the evening.

#### **Sunday 10<sup>th</sup> October 2010**

Morning tablet, evening tablet.

#### **Monday 11<sup>th</sup> October 2010**

Morning injection - Dr Ana Claudia then changes dosage to forced oral ingestion, first being that evening.

#### **Thursday 14<sup>th</sup> October 2010**

Plaintiff pleads with Dr Ana Claudia to cease her action, her reply '*I'm sorry that's something I cannot do.*'

**Monday 18<sup>th</sup> October 2010**

Plaintiff is escorted by Head Nurse to Hospital reception area where he is met by Allesandro Santos da Silva and wife Jessica, in a tearful state they offer to take plaintiff home. Head Nurse is nowhere to be seen and plaintiff walks out of Colonia Santana main entrance and enters Allesandro's Car.

Sick with heavy flu, severe diarrhoea, sweating Haroperidol out of forehead and experiencing regrowth of paralysis disease in hands, plaintiff believes Dr Ana Claudia had telephoned his friends informing them of whereabouts.

**Total Haroperidol dosage of 5 injections, 3 tablets and 14 forced oral ingestions over period 7th – 18th October 2010.**



Diarrhoea ceased 24<sup>th</sup> October, exited flu 28<sup>th</sup> October – paralysis disease combatted with 'Lapacho tea' (Lapacho being principle ingredient of 'Flor da Amazonia'). Three weeks of lethargy followed.

#### **Long Term Consequence of Experimental Haroperidol Dosage**

- Shrinkage to frontal lobes of brain, damaged and clotted blood capillaries deep inside brain.
- Discomfort to left side of brain felt on roof of mouth and above left ear, shrinkage being left side bi-ased.
- Dosage flooded front region of brain, chemically scolding eyes resulting in permanent slightly blurred vision.
- Oral digestion has damaged bowels perhaps the pancreas resulting in highly problematic digestion.
- Lowered attention span and concentration resulting in reduced artistic output.
- Spring 2021 consumption of butter resulted in stinging pains to right side of brain and tremor to wrist
- October 2022 cold water surf session resulted in torsional load to left side of brain, stinging pains to right side, dizziness and almost blackout. Followed by a prolonged feeling of being wacked on the back of the head, consequence being expenditure on private health care for MIR scan of brain 21st October

During incarceration plaintiff always acted calmly with politeness and was never a physical threat to himself or others.

#### **Observations**

Secure ward policy being 'All patients/ inmates to be medicated'.

Patients/ Inmates of the secure ward are provided with tobacco as reward for consuming medication and fed 5 times a day.

Limited exercise resulting in many long term patients being pot-bellied tobacco addicts.

Hospital practice in breach of the Nuremburg Code (guidelines for medical experimentation

Hospital an annex to a Catholic Mission, a Priest doing ward visits, infringing 'The Nuremburg Code' as to medical experimentation.

## Antipsychotic deflates the brain

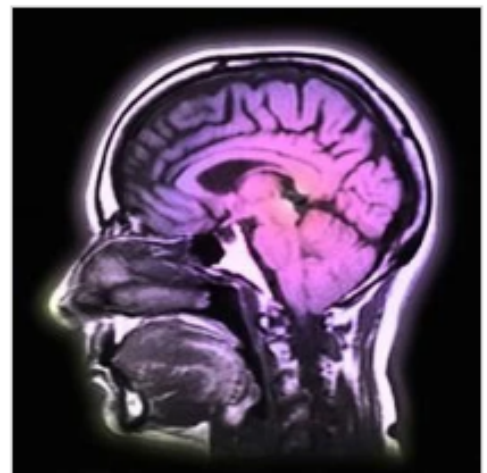

**Drug for schizophrenia causes side effects by shrinking part of the brain.**

A leading antipsychotic drug temporarily reduces the size of a brain region that controls movement and coordination, causing distressing side effects such as shaking, drooling and restless leg syndrome.

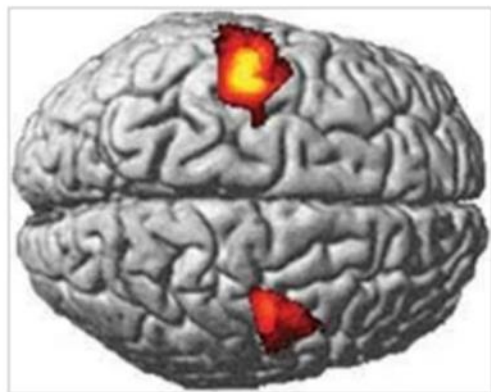
Just two hours after injection with haloperidol, an antipsychotic commonly prescribed to treat schizophrenia, healthy volunteers experienced impaired motor abilities that coincided with diminished grey-matter volume in the striatum<sup>1</sup> – a brain region that mediates movement.



A commonly-prescribed antipsychotic drug shrinks the brain within hours of administration. Credit: Jim Wehtje / Photodisc / Getty Images

"We've seen changes in the brain before, but to see significant remodelling of the striatum within a couple of hours is staggering," says Clare Parish at the Howard Florey Institute for brain research in Melbourne, Australia, who was not involved in the study. "Our viewpoint was that only chemical changes would happen in such a short time."

"This is the fastest change in brain volume ever seen," says Andreas Meyer-Lindenberg, professor of psychiatry and psychotherapy at the University of Heidelberg in Mannheim, Germany, and a lead author on the report in *Nature Neuroscience*<sup>1</sup>. "Studies have found that the volume of brain regions changes over a number of days, but this is in one to two hours, and in half that time it bounces back."



Haloperidol shrank volunteers' striatums in two hours, but they bounced back within a day. Credit: Tost, H et al.

Within a day, volunteers' brains returned to almost their original size as the effects of the single haloperidol dose subsided. Meyer-Lindenberg says this result should alleviate fears that the drug destroys brain cells. "We know it's not killing neurons because the brain rebounds," he says.

In functional magnetic resonance imaging (fMRI) scans the authors observed the participants' striatal volume diminishing and changes to the structure of the motor circuitry in their brains. Further, their reaction times slowed in a computer test taken after the treatment, indicating the onset of lapses in motor control that affect many patients on antipsychotics.

### **Dopamine downsizing**

Haloperidol has a number of side effects, although many of these are minor and recede within weeks of starting treatment. With few better alternatives, psychiatrists have prescribed the drug for more than 40 years to treat people suffering from hallucinations, delirium, delusions and hyperactivity.

Like most antipsychotics, haloperidol blocks the D2 receptor, which is sensitive to dopamine. The drug stifles the elevated dopamine activity that is thought to underlie psychosis. D2 receptors are abundant in the striatum, where their activity regulates gene expression. But, until now, no one knew that blocking the receptors would rapidly alter the brain's physical structure.



Instead, the team suggests that haloperidol downsizes synapses, the junctions through which neurons communicate. Meyer-Lindenberg speculates that the change is mediated by the protein BDNF, which is involved in synapse growth and diminishes in response to antipsychotic treatments in mice.

### The bigger picture

"I think this study will cause worry to some," says Shitij Kapur, dean of the Institute of Psychiatry at King's College London. To counteract those fears, he notes that the brain changes caused by the drug seem to be reversible and that the dose used in the study was a little higher than that usually given to patients who had not taken the drug before.

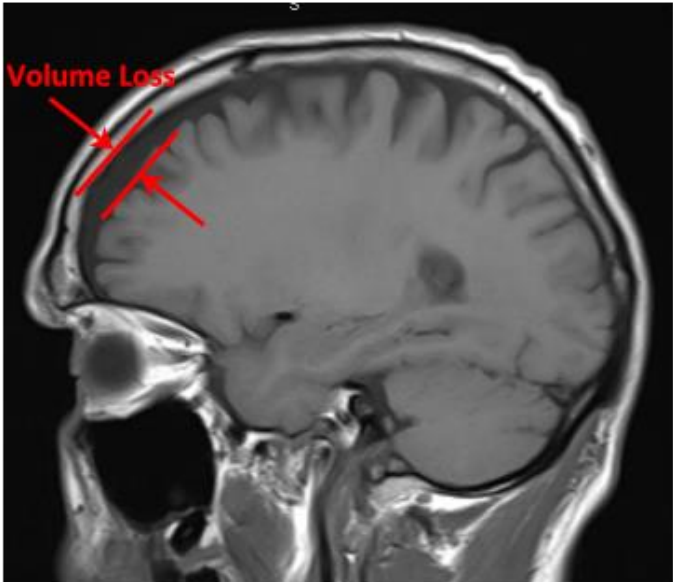

## Incident 3

### Chef Delegado Christiano Bath's Corruption of Dr Allesandre

**Location - Colonia Santana, Psychiatric Hospital, Santa Catarina, Brazil.**

#### **Monday November 22<sup>nd</sup> 2011**

Rising early to collect discarded aluminium cans at a park with football pitch local to plaintiffs abode in Estreito, Florianopolis. Plaintiff is detained by Police accused of 'messaging with a ladies bag' and returned to the same ward of the Colonia Santana.

A patient of Dr Allesandre who liked to practise his English, he could not provide a diagnosis of mental illness and told plaintiff he would be free to go after three weeks.

#### **Week Ending December 17<sup>th</sup> 2011**

Protocol for plaintiff deportation is confirmed by Chef Delegado Christiano Bath, incarceration at the Colonia Santana is to last 60 days and Dr Allesandre is to accompany plaintiff on flight to London scheduled for 28<sup>th</sup> January 2012.

Dr Allesandre then provides diagnosis of Schizophrenia and plaintiff asks him:-

*'In what way am I showing signs of schizophrenia?'*

His response was a wink and a smile and plaintiff is told that if he takes the medicine then what he has will pass by like the flu.

Plaintiff wishes it be noted that life in Brazil for an English speaking gringo communicating with those educated or partially educated in the English language, often results in the conversing pair mixing the two languages as relevant vocabulary may be lacking by one or the other.

Dr Allesandre classifying plaintiff as a schizophrenic while plaintiff considers himself as having become bilingual, resulting in plaintiff making the conscious decision to escape from the hospital and report to the local army barracks to whom he had been making presentation since April 2011.

#### **Wednesday 5<sup>th</sup> January 2012**

Assisted by Nurse Elizabeth who provides plaintiff with a change of clothes which plaintiff hides under his mattress (clothes worn in the hospital are stamped with the letters IPQ). Plaintiff successfully escapes from the Colonia Santana at the end of a therapeutic cookery class, by slipping out of the cookery class kitchen during washing up.

A baseball cap hiding plaintiffs face from security guards and in the un-stamped clothes plaintiff takes a very long brisk walk back to abode in Estreito and collects a substantial amount of artwork for proposed gameshow *'Time Tunnel – Atari Alliance'*. The following day being the first Thursday of the month plaintiff's host Allesandro Santos da Silva arrives at the property to collect rent from three separate families occupying the house.

Plaintiff spends the week sleeping on beach Praia Mole where 9 years earlier he had learnt to surf and feeds himself through sale of collecting discarded aluminium cans.

#### **Friday 13<sup>th</sup> January 2012**

Plaintiff hikes to Florianopolis City and reports to the Army Barracks, calling on public relations officer Captain Carlos Lima who gives him 15 Reais for food and tells plaintiff to come back on Monday. Plaintiff spends the weekend at local bus station.

Plaintiff's presentation to the Army being made because he didn't wish to leave the country without having shown a military representative the location of Ark storage site central to Ilha Santa de Catarina.



## Incident 4

### Chef Delegado Christiano Bath's Corruption of Dr Marco Antonio Rocha

**Location – Hospital Wing of the State Penitentiary of Santa Catarina, Florianopolis, Brazil.**

**Monday 16<sup>th</sup> January 2012**

Reporting to Army Barracks plaintiff is allowed to enter and is escorted to the refectory and enjoys a large lunch. Conversing with Captain Lima, the public relations officer expresses desire to house plaintiff at the barracks and accompany plaintiff to London. Plaintiff is then left waiting in the reception area while Captain Lima reports to his Colonel.

Federal Police Officers arrive at the Army Barracks Reception, plaintiff is handcuffed and taken to the hospital wing of the State Penitentiary.

Plaintiff commences another 60 day protocol for deportation this time in an isolation cell.

A patient to Dr Marco Antonio Rocha who informs plaintiff *'You shouldn't be in here as this prison is for murderers, thieves and drug dealers..... he sees no sign of mental illness and won't put plaintiff on any medication.'*

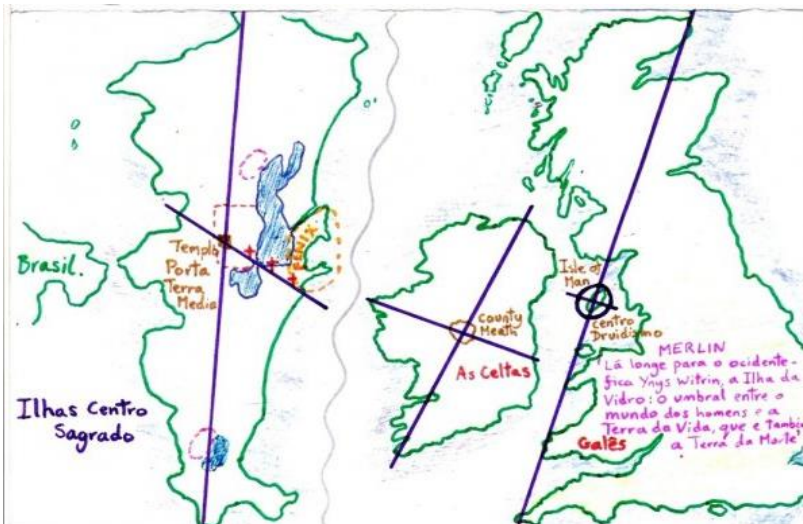
A few days into this incarceration plaintiff is visited by Captain Lima accompanied by a Catholic Priest. Questioning faith plaintiff declares to be a follower of Buddhist philosophy the Priest responds mentioning Catholic Saint Francis of Assisi. Plaintiff's objection to forced medication policy of the Colonia Santana is discussed and plaintiff is satisfied that Dr Marco Antonio Rocha agreeing to not prescribing medication. Plaintiff request's Captain Lima to recover artwork left with Allesandro da Silva. Captain Lima stating that plaintiff should have come to the army first and not the police.

A visit follows by members of the Jehovah Witnesses who later deliver clothes for plaintiff's trip to London (stolen by inmates/ staff!).

Three weeks into this incarceration and accustomed to prison routine plaintiff is engrossed in writing an autobiographical tale of how life had taken him from a Cambridgeshire village to a Brazilian prison cell. Theme of story being how key passages of printed text take us from one chapter of life to another, examples being a University prospectus taking plaintiff to a life in Leeds; a Yorkshire Post advert taking plaintiff to employment with an Iranian carpet fibre manufacturer and a Fobers guide to Brazil purchased in Clapham Junction taking plaintiff to Joaquina Beach to learn to surf...

Twice weekly consultancies with Dr Marco occur; he expresses his interest in the Christian Jacq Ramses novels, his recent viewing of film Iron Lady and complements plaintiff with Leonardo da Vinci!

During these meetings Dr Marco takes no notes and continues to hold belief that plaintiff shouldn't be there in the Hospital wing of the state penitentiary.



Plaintiff's first meeting with Dr Marco confesses that knowledge of Celtic sacred cartography of the British Isles applied to Ilha Santa Catarina took him to the top of a mountain at the geographic island centre. First discoveries made five years earlier revealing the 'Sword in the Stone' and a tunnel entrance closed with stone masonry of medieval castle builders.

Celtic folklore providing the legend of Tir Na-Nog the Land of the Forever Young.

A later meeting plaintiff demonstrates natural chimpanzee quadruped gait and slightly crooked nose explaining that the commencement of studios project supporting archaeological expedition coincided with plaintiff recapitulating childhood assaults inflicted by his father. Plaintiff informs Dr Marco that he had exited an approximate 34 year period of traumatised shock.

**Friday 17<sup>th</sup> February 2012**

Called into Dr Marco's consultancy room he is accompanied by nursing staff and plaintiff is informed that they are going to commence medication.

Protocol for deportation being confirmed and a date set for 7<sup>th</sup> March, Dr Marco will be accompanying plaintiff along with Chef Delegado Christiano Bath on the flight to London.

Plaintiff is given access to a computer and Facebook account, plaintiff shows photos and subsequent artwork of archaeological discoveries to Dr Marco.

Dr Marco then acts stupid pointing at the screen displaying the 'Sword in the Stone' saying in his German accent:-

*'Is that Engerland, is that Engerland...??',*

Plaintiff reply *'No it is here in Brazil.'*

Dr Marco replies *'You have too many ideas!'*

Plaintiff's thought's were *'But I've been referred to as a creative genius'*

For the following three weeks plaintiff is forced to ingest Lithium, Dr Marco providing false diagnosis of *'Bipolar Disorder'*.

On receipt of plaintiff's Mental Health Record 2022, plaintiff reads that Dr Marco made defamatory statement that *'Plaintiff want's to kill his Dad.'*

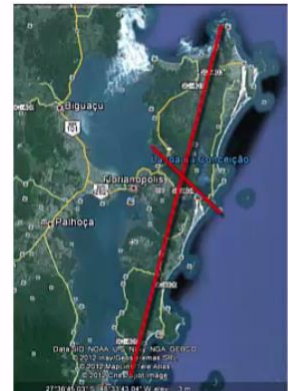

Accompanied by four Brazilians, plaintiff arrives at Heathrow Airport in possession of artwork delivered by Captain Lima two days earlier and a hand written manuscript titled '*I Know You're Gonna' Dig This – How I found the Ark of the Covenant and the Assassination of Character*'.

Chief Delegado Christiano Bath and his wife, a second Federal Police Officer and Dr Marco all taking a vacation in the St George's Hotel, Pimlico, London.



## Observations

A false diagnosis of Bi-polar disorder provided by Dr Marco, his reward being a holiday in London.

Chief Delegado Christiano Bath was first informed of Studios Project and Archaeological discoveries March 2009 when plaintiff was resident at the Candice Apartments, Joaquina Beach and the British Foreign Office had requested plaintiff make a statement. Instead of sending a Government Representative to witness discoveries, plaintiff believes a Policeman named Milton came to 'work' at the Apartment Block – his demeanour always being hostile and unpleasant towards plaintiff.

## 5. Paralysis Disease - The Wormwood

Holy Bible - Revelations 8:10

*“The third angel sounded his trumpet and a great star blazing like a torch, fell from the sky on a third of the rivers and on the springs of water - The name of the star is Wormwood.*

*A third of the waters turned bitter, and many people died from the waters that had become Wormwood.”*



My mother Wendy Mary Parker - born in Malta 4<sup>th</sup> April 1942, died in Hinchingbrooke Hospital, Huntingdon 31<sup>st</sup> November 2002 aged 59.

Following over 25 years employment in Hinchingbrooke Hospital, my mother resident in Brampton village, began to experience paralysis of her left foot and ankle nine months into her retirement during September 2000.

Throughout my mother's illness concern was that she was suffering from Motor Neuron Disease (MND). However, classic symptoms of MND are that facial muscles are affected and the patient is unable to smile, a classic case being Stephen Hawking who lived with MND for 55 years, symptoms my mother's condition didn't share.

My mother regularly saw consultant neurologists and even travelled to London to do so and for over two years no doctor was able to provide a diagnosis for her condition, as it slowly spread up from her ankle – consuming both her legs.

In the spring of 2002 my mother agreed to an experimental treatment consisting of transfusion of blood plasma. Her paralysis then crept up through the torso and she died from respiratory failure November 2002. Her condition only being diagnosed as Motor Neuron Disease **after** she had received the experimental treatment.

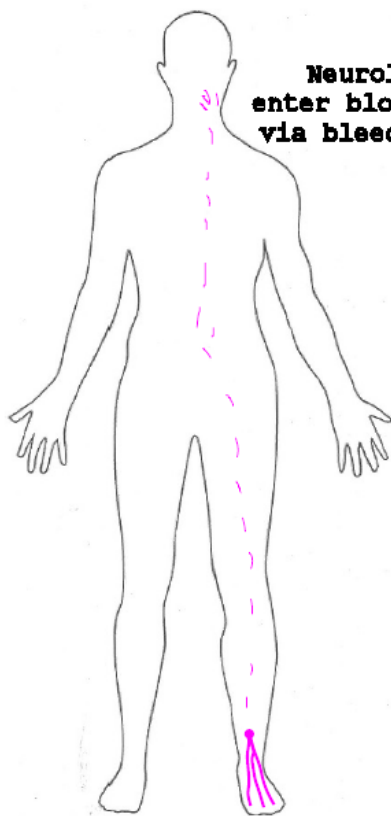
While employed in the Aerospace industry of Brazil – August 2001, I travelled to Phoenix Arizona to meet Donald Byrn. Mr Byrn assisted by Mormon missionaries was providing a treatment for MND sufferers – an extract of peanut shell to help repair the central nervous system. In the USA MND is called ALS (Amyotrophic Lateral Sclerosis), paralysed for over twenty years Mr Byrn had been in trouble with the ALS society of the USA – he told me in person that he believed he had got sick through drinking from a hosepipe on farmland.

Two years after my mother's death and sleeping under the Ark of Ruling Consciousness in Lagoa da Conceicao, October 2004 a dreamed experience resulted in rupturing my left side vas-deferens, semen entering my bloodstream. Dreams followed of my left side turning to wood, my eye becoming a knot – 16 months later I began to wake from sleep with paralysis of left hand fingers.

Experiencing onset of this paralysis disease resulted in the risks taken of exploring the forest central to the mountainous centre of Ilha Santa Catarina. February 2007 the disease synapsed across my neck and very efficiently paralysed my right arm. I fought these attacks off by shaking my arm back to life, doing press-ups, surfing and playing guitar – all attacks entering sleep or during sleep preceded by a slight tremor to the limb infected.

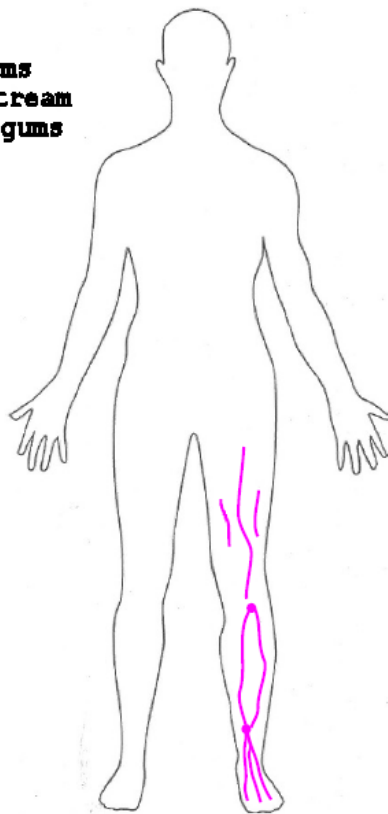

My father visited Brazil in February 2007, he insisting that I return to UK to see the same doctors as my mother. Following my father from a distance back to his hotel room I stopped at a medicinal tea vendors stall owned by a tall one eyed indigenous Indian, I explained my condition and he sold me the remedy 'Flor da Amazonia' - a traditional remedy to treat parasites.





Prior to finding this remedy I had become an out-patient at Florianopolis University Hospital. They having a substantial Toxicology department I became a student of snake bites and insect stings and learned that on being bitten by a snake to wrap the limb in mud – the mud providing a natural transfusion of water from flesh to the mud assisting in removing toxins.

A patient to Dr Mario I provided blood, faeces and semen samples for inspection. Concern that it was an infection of the testes I was referred to psychiatry.

I was celibate for over eight years.

There exist many paralysis diseases, but on attending my Hinchingsbrook school reunion party in November 2016 I learnt that two of my class-mates mothers from Brampton Primary School had recently lost their mothers from a paralysis disease. Those class mates being Kriston Pring and Victoria Evans. In 2012 I also encountered a third resident of Brampton village experiencing onset of a limb paralysis disease his name is Simon, a homosexual, and member of Huntingdon Drama Club. In presentation to the Jehovah Witnesses of Huntingdon, family Marshall had lost their grandmother to a paralysis disease.

Prior to my mother's death I had this vivid dream experience:-

*'I am in the back garden of family home in Brampton, sat at the picnic table are aerospace work colleagues from Connecticut – they discussing technological development of metallurgy. I am then swinging a golf club which highlights the word Titanium and in the garden appear 'puffer spores' of a 'killer mist', dream ends with a view of my mother dead with her head submerged in the stream at the foot of the garden'*

My family moved to Brampton village in 1976, our garden separated from a field used for intensive cereal farming by a stream acting as a drainage ditch. On arriving during the 1970's this stream was full of life - today it is not.

As a screenwriter I have produced story 'The Golden Dolphin' which contains the following scenes:-



The Electric City's culture had convinced farmers that exploiting the soil was the right thing to do...



**But when it rained fertilizers containing Nitrates, Phosphates and Titanium ran off the fields into the rivers and lakes.**

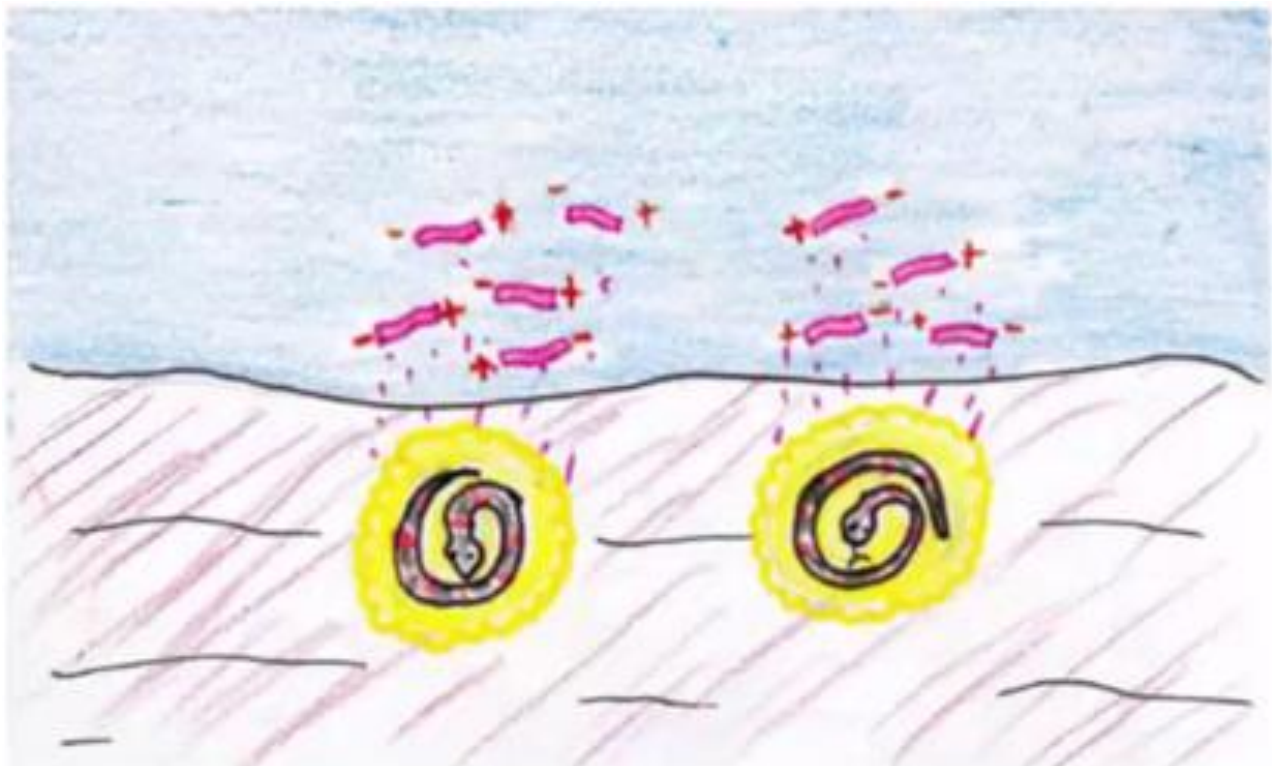

I regularly take Lapacho Tea, the inner bark of South American tree Ipe Roxo and primary compound of original cure Flor da Amazona. I have mixed this with hair gel to make a skin/ teste application and more recently I have found taking Boots Threadworm (Mebendazole) tablets to be the most effective treatment.

Dear John Woods

I am writing to you from Newquay Cornwall where life as a Surfer revolves around the ocean swells coming and going. My family residing in Cambridgeshire since 1973 following the posting of my father (deceased 2016) to RAF Wyton and then Brampton. Currently aged 53 last month I was in Huntingdon to attend Priory Fields Surgery for my annual medical and learnt of your health condition from the 21<sup>st</sup> June edition of the Hunts Post newspaper. Journalist Debbie Davis informing that funds had recently been raised for the Arthur Rank Hospice Charity and the Motor Neuron Disease Foundation by cycling around Grafham Water Reservoir.

My mother (Wendy Mary Parker) died in Hinchingsbrooke Hospital Huntingdon from a paralysis disease in November 2002, I having been living in Brazil since 1999 employed as a Design Engineer in their aerospace industry. My mother's illness commenced in September 2000 with her left foot and ankle becoming lame only nine months into her retirement following 20 years employment within Hinchingsbrooke Hospital. My mother's condition spread up her left leg and by the spring of 2002 she had lost use of both her legs. Consultant neurologists including those practising in London over this almost two year period were unable to provide a diagnosis fear being that it was Motor Neuron Disease, however my mother's illness did not show 'classic symptoms' of losing the ability to smile. In the spring of 2002 Wendy Mary Parker received an experimental treatment involving transfer of blood plasma, following this her condition worsened, the paralysis accelerating up through the torso eventually causing her death. Consultant neurologist only confirming Motor Neuron Disease **after** having administered experimental treatment.

During August 2001 via the internet in Brazil I surfed across the American Mr Donald Byrn who had spent many years battling against his diagnosis of ALS (Amyotrophic Lateral Sclerosis the American term for MND). Travelling to his home in Phoenix Arizona I met Donald and two of his assistants that were Mormons running his cause named 'New Hope Appeals'. Donald offering treatment to restore the central nervous system derived from peanut shell extract, the active substance being **Luteolin** which can also be found in celery sticks. Questioning Donald face to face he told me via an assistant, as he was surviving via a mechanical respirator, that he believed his condition had been caused via drinking from a hosepipe on farmland.

Our Brampton family home garden bordering a cereal crop field via a drainage ditch, my mother's death affected me very much. Having lost engineering employment due to the 911 felling of New York's twin towers, aged 32 I committed myself to childhood dream of surfing and based myself in Ilha Santa Catarina off the south coast of Brazil. Returning to this location after a successful surf trip to South Africa August - September 2004 I had been befriended and encouraged by local professionals and continued to train fulltime. However, life took an alternate path in October 2004 following the rupture of my left side vas deferens and semen entering blood stream, 15 months later I began to experience onset of a paralysis disease that commenced in the outer two fingers of my left hand.

As the disease spread up my arm I observed 'growth' occurred during sleep, as life became a Nightmare on Elm Street fighting off my arm going lame I practised guitar, press-ups and surfing. Trying not to go to sleep I would experience tremor of my left wrist as the 'infection' would create nodal spores up my arm that would

then connect and similar to a flicking of an electrical switch the limb would be paralysed and I would shake it back to life. I learnt that the infection was linked to my metabolism and noticed coffee (caffeine) would accelerate growth, the toxins of smoking a cigarette would quell growth and occasional smoking of marijuana would lower my metabolism and encourage infection's growth.

Paralysis attacks culminated 12 months after first attacks to left hand outer fingers with the infection synapsing across the nape of my neck and highly efficiently leaving me with both arms and hands paralysed, shaking them both back to life - days followed of trying to not go to sleep by doing press-ups until I dropped.

This was February 2007, housed by a hotel owning family that had been witness to my activity since infection onset my father was invited to Brazil and following him back to his hotel in downtown Florianopolis capital city of Santa Catarina, I stopped at a market stall selling medicinal tea managed by a tall well-built Indian gentleman lacking sight in one eye. Explaining my condition he prescribed a traditional remedy for parasites named 'Flor da Amazonia' below is a scan of a packet providing this medicinal compound.

Translating the paragraph 'Indicacao' = 'Recommendation' provides 'Sistema Nervoso' = Central Nervous System and 'Vermes em Geral' = Worms in General.

Since returning to the UK in March 2012 (I was deported by Brazilian Federal Police) I have been regularly taking medicinal tea 'Ipe Roxo' principal ingredient of 'Flor da Amazonia' which is sold in Europe under alternate name 'Pau D'Arco' or 'Lapacho', it's the inner bark of a tree native to South America. Living in a motorhome the morning chill causes the outer two fingers of both hands to be slightly lame and wiggled back to life and if I'm lazy or sunbathing exposing my back to the Sun I experience an involuntary spasm to my lower back where I believe a spore of 'Neurol Worms' (worms the size of a neuron) are slowly attacking my spinal column.

My attempts to present my experiences and discoveries to the NHS have so far been unsuccessful and hope you don't mind that this presentation to you John Woods of St Neots in the Ouse Valley be a part of my next presentation.

In November 2016 I attended a class of 1986 Hinchingsbrook School reunion and learnt that two of my class mates and residents of Brampton had recently lost their mother's to a paralysis disease diagnosed as MND and attending Jehovah Witness reunion in Huntingdon I learnt that the grandmother of another classmate had died from MND.

Fully understanding the 'hope' that terminally ill patients cling too I could not but write this letter to you and provide you with a packet of the same medicinal tea I am taking.

## 6. Near Fatal Infestation of Ascaris Worms

April 2011

Location – Favela Estreito, Florianopolis Brazil

Cause – unknown

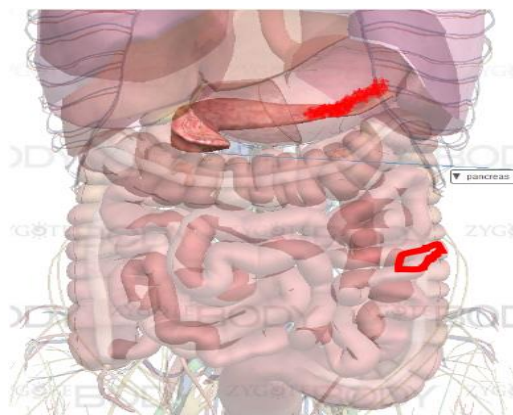
Onset – December 2010 two months after assisted escape from Colonia Santana Psychiatric Hospital. Observe two large worms, similar in appearance to beansprouts, in faeces about 3 times a week.

April 2011 – Eating a meal of rice, beans and eggs while camping in Joaquina Beach Dunes – experienced severe abdominal pain as worm infestation multiplied. Large worm exiting anus – presentation to Medical Centre (Posto de Sauade, Lagoa da Conceicao) Doctor provided prescription for 5 large Albendazole tablets – cost R\$25. My income at that time was from that of hustling car drivers for change as I watched their cars parked in the street. Unable to purchase medication, another 3 days passed – hiking in dunes experienced excess saliva with a soapy taste. Visited friend known as 'Boca the mechanic' – told him 'I was going down!'. He purchased the 5 Tablets – I then passed about a basketball quantity of dead worms over the next few days. Thanks to Boca I am writing this today – believe I was a few hours away from worm growth up my throat and down into my wind pipe!

A dream followed of the *'Grim Reaper slicing my tent in two, with me in it, his blade brushing my left shoulder'*. My appearance then being of very little body fat.



### Ascaris Worms



August 2019 – Believe excessive internal pressure of worm infestation caused 'Leaky Gut Syndrome' combined with damage to Haloperidol ingestion. Some food, particularly wheat products, induce bowel pain in region indicated.

Bone broth and rice based diet seems best. Regular use of probiotics, fibre gel and collagen. Recent meal of several steaks induced diarrhoea – several weeks passed and observed much food was not being digested.

March 2022 – Intestinal damage may have become an intestinal cist, am taking apple cider vinegar, garlic, honey and cayenne pepper as natural antibiotic.
