**Ref: Establishing Los Angeles Embassy to Significant Religious Object – Ministry of Defence Contract, Brazilian Expedition Party.**

This letter being shared with John Swinney of the SNP and my godfather retired RAF station commander Maurice Arnold – printed letter copies enclosed.

For the first time since commencing presentation to your predecessor in June 2019 I am relying on a House of Commons address, my previous deliveries were made to the Huntingdon Conservative Association office at Centenary House, St Mary's Street Huntingdon. In June of this year I found this building to have been closed and boarded up so made delivery to 20 High Street believing this to be constituency address for Jonathon Djangoly as his recorded constituency address on the Stukeley Road did not exist.

Provided with this correspondence is a USB pen drive and folder <Letters of Introduction/British Government> contains my previous letters and as introduction to you I request reading my first letter to Jonathon Djangoly delivered in June 2019 *'MP for Huntingdon Jonathon Djangoly 1'* and my last of June 2024 *'Huntingdon MP Djangoly and John Major 1'*. Having had no response from Djangoly I commenced presentation to the Chief of Cambridgeshire Police and June 2024 letter *'Cambridgeshire Police 4'* requested introduction to John Major.

My deportation from Brazil in March 2012 was consequence of attempting to update a statement made to the Federal Police of Florianopolis Ilha Santa Catarina that had been requested by the British Foreign Office in early March of 2009 and taken by Chief Delegado Christiano Bath and invite your review of document *'Advocacy Preparation'*. Preparing to open a case of prosecution I request that you could make enquiry as to the Foreign Office's correspondence with Florianopolis Federal Police 2009-2010.

In December of this year I shall be in Huntingdon to attend an annual medical at the Priory Fields Surgery, for twelve years this medical includes questioning that is totally irrelevant to my true state of health and invite your review of *'UK Mental Health Review Request - November 2023'* USB pen drive folder <Letters of Introduction/British Government/Cambridgeshire Mental Health> and presentation in folder <Letters of Introduction/British Government/Wormwood>.

Living under a false diagnosis of mental health I believe is inhibiting progress in the following:-

- Acknowledged by the professional medical community of a muscle paralysis disease caused by water born parasite.
- The Ministry of Defence awarding an Engineering Contract see letter *'Foreign Secretary - David Cameron'*
- My successfully qualifying for a Private Pilot License.
- Successful prosecution of three Brazilian Nationals (negotiation presented in letter *'Masonic Lodge Ilha Santa Catarina 1'* USB pen drive folder <Letters of Introduction/Masonic Lodges and Armed Forces>).

As a former Army officer I invite your review of letter *'Huntingdon Mayor 3'* which concludes with the following paragraph – *'It was consequence of the death in 1998 of my maternal grandfather Lt Col Lionel Dollery of the Royal Engineers Regiment that I relocated to Brazil to further my own engineering career and in 2020 composed an introductory letter to 'Chief Royal Engineer Lieutenant General Tyrone R Urch' see CD rom folder 'Previous Letters of Introduction'. My approaching British Armed Forces directly would be futile as any correspondence would probably be returned or regarded as hoax material. So I wish to invite the office of Huntingdon Mayor to consider assisting formation of an expedition party of which the Royal Engineers Regiment would take precedence and my elder brother's services could be utilised for a topographic land mass study of Ilha Santa Catarina. I am best contacted via telephone number provided at head of this letter.'*
