Dear Captain Lima

I hope you and family are keeping well and all is peace and tranquillity in sunny Brazil, eleven years have now passed since our last meeting in the State Penitentiary of Florianopolis and I am very grateful for your returning conceptual artwork pertaining to proposed gameshow '*Time Tunnel – Atari Alliance*' which I still carry with me and make presentation of.

Sadly on returning to the UK in 2012 my family did not make life easy for me as no member would welcome me into their homes, my father died in 2016 and my elder brother Ian Robert Lionel Parker, as far as I know, is still employed with the NATO Intel Fusion Centre at RAF Molesworth, Cambridgeshire – he furthering a career in aerial reconnaissance and munition targeting. In receipt of UK social security payments I have persevered over the last eleven years in presenting archaeological discoveries made on Ilha Santa Catarina and during the last winter months have expanded a set of four dossiers under the group heading '**Establishing Embassy to Significant Religious Object(s)**' their titles:- '**Lifting the Veil; Camaialot; Grail Technologies; The Anunnaki Conquest of the Free World**'. This winter's commitment contributed '*Camaialot B*' and '*Anunnaki Conquest C*' – dossiers are available for viewing at website www.apollobath.org link *Crown Office and Embassy*, due to their content dossiers *Anunnaki Conquest B & C* are not available via website but included on enclosed CD.

Consequence of time spent in Venezuela 2018-19, my host being a former student of screenwriting in Hawaii, has enhanced chapter 4 of dossier '*Camaialot B*', provided chapter 23 of '*Anunnaki Conquest B*' and I wish to invite your review/ approval of artworks provided prior to presentation to **CELAC**'s head office in Caracas.

I understand prior to my deportation from Brazil in March 2012 you had been in contact with my father via email, I wish it be known that my father had a friendly relationship with his cousin a Dr Jimmy Findlay of Johannesburg, South Africa. I believe Dr Findlay's career as an Entomologist with Monsanto in South Africa was assisted by his local Masonic Lodge and at my mother's funeral in December 2002 his son Iain Findlay was in attendance while serving with the Black Watch British Army Regiment of Scotland. Following the funeral and drinking beer at the bar Major Findlay demonstrated handshakes used by Freemasons.

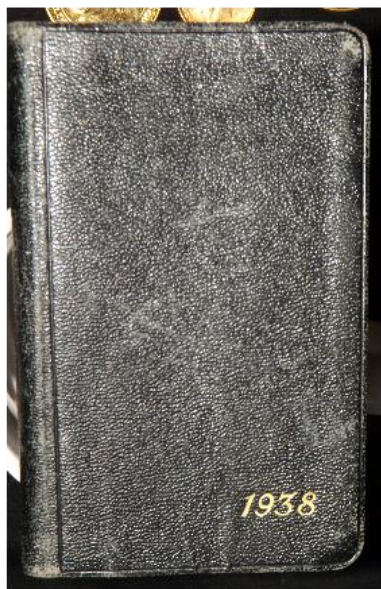
Prior to selling my London home in 1999 and re-locating to Sao Paulo three books purchased from a Clapham Junction bookstore (Clapham Junction being the hub of London's extensive railway matrix) resulted in the discoveries made on Ilha Santa Catarina from 2006 onwards. These books being:- a *Fodders Guide to Brazil* informing Joaquina Beach to be Brazil's premier surf spot; *The Fire Within* – Carlos Casteneda's lessons of Don Juan the Mexican Yaqui Indian conveying knowledge of the ancient Toltec *Seers*; *The Hiram Key* which presents the origins of Freemasonry and construction of Rosslyn Chapel, Scotland.

During incarceration at Florianopolis State Penitentiary I became engrossed in writing an autobiographical tale of how life had taken me from a small Cambridgeshire village to an isolation cell in Brazil – core storyline being how key passages of printed text take us from one chapter of life to another, one example being a university prospectus that had taken me from Cambridgeshire to Yorkshire in 1988.

Last year I obtained copy of statements made by Dr Marco Antonio Rocha, prison psychiatrist to Florianopolis State Penitentiary, who for the first month of my incarceration repeatedly stated that he saw no signs of mental illness, declaring that I shouldn't be in here. However, his comments made in writing are that '*I want to kill my dad*', during his consultancies he made no written

statement until after the 17th February 2012 - the date that he was informed he would be accompanying me on deportation flight to London.

The book 'The Hiram Key' informs the reader that Jesus Christ said 'One should bury your father', following my father's death I gained access to his home office desk and found a Nazi Party diary dated 1938 the year of James Ronald Parker's conception while his father, a Sinclair Clansman who died 12 years prior to my arrival, was employed in Leeds Yorkshire as a Doctor of Medicine in General Practise.



Written in my father's hand on the inside rear cover of this item of military memorabilia is a list of German names who I believe may have assisted James Ronald Parker procure teenage prostitution. I believe Mr Parker was gifted this diary by those that be-friended him following my mother's death, as he walked down his memory lane of being a young British Army Officer drinking strong lager frequenting German Brothels, reminiscing the days prior to meeting his wife.

My mother met Mr Parker while he was serving with the Royal Tank Regiment in post war Germany, my maternal grandfather having had a life-long career with the Royal Engineers, retiring to become Mayor of his hometown as a Lieutenant Colonel.

Included on enclosed CD is document titled *Curriculum - Mental Health Review Request* which informs the reader as to the deceased Mr Parker's relationship towards his youngest son being that of a *Sociopath/ Pathological Liar with Paedophile Tendencies*.

Dossier *Anunnaki Conquest of the Free World part C* concludes with two appendices that detail the actions of Federal Police Officer Christiano Bath and injuries sustained following sale of my body for medical experimentation to the Roman Catholic Church – this incident features in music video *The Killing Moon*.

I am not of the legal profession but believe I have the right to pursue cases of prosecution against the following Brazilian nationals:-

Christiano Bath :- Instigating abduction of a British National and composing false statements to incarcerate in a secure psychiatric ward.
Corrupting a Hospital Psychiatrist to provide false mental health diagnosis, offering a short vacation in London, England. (I escaped and reported to Army Barracks)
Corrupting a Prison Psychiatrist to provide false mental health diagnosis, rewarding a short vacation in London, England.

Dr Marco Antonio Rocha: - Providing false mental health diagnosis and defamation of character.

Dr Ana Claudia: - Prescribing an experimental dosage of an anti-psychotic medicine, an act of malicious intent, her employer's in violation of the Nuremburg Code for Medical Experimentation.

Florianopolis Federal Police first became aware of my Brazilian activities in March 2009 following a request from the British Foreign Office for provision of statement. Collected from the Candice Apartments of Joaquina, Chef Delegado Christiano Bath recorded a lengthy statement which I concluded with the phrase '**My actions are in the best interest of delivery of the Ark of the Covenant to Brazil and the future generations**'. It was consequence of the kindness provided by Dna Veira Desjardins of Joaquina Beach, from 2007 onwards that **Banco Atlantida** was devised, see chapter 10 of dossier *Camaialot A* and website www.apollobath.org – link – *Banco Atlantida*.

Departing from Guarulhos Airport on the 7th March 2012 whilst urinating alongside Christiano Bath, this Federal Police Officer mentioned that I can return to Brazil but may have to pay a fine. Wishing to continue to act in best interests of Brazil's future I am prepared to **not** pursue prosecution of Christiano Bath and Dr Marco Antonio Rocha if the Masonic Lodge of Ilha Santa Catarina or the Brazilian Army are supportive of and willing to take a shared interest in Banco Atlantida or some other positive form of collateral management.

I believe that best interests could be achieved by introducing discoveries to both South African born **Elon Musk** and **DeBeers Ventures** <https://ventures.debeersgroup.com/>, the DesJardins family of Joaquina gaining a controlling Brazilian interest in associated Gold bullion see document **Banco Atlantida – Gold and Bibliotheca**.

Chapter 7 of dossier *Camaialot A* introduces Elon Musk he being identified as *2 of Clubs – Kin 146 Electric World Bridger* whose business interest **The Boring Company** could be well utilised and Chapter 15 of the same dossier introduces DeBeers Ventures together with White Diamonds, Jewellery Projects and Melania Trump.

Following my father’s death in 2016 I retrieved a second item of military memorabilia – a coffee mug originating from the NATO Intel Fusion Centre and gifted last year as introduction to BACE Brazilian Aeronautical Commission in Europe, 16 Great James Street, London WC1N 3DP.



Hoping that approaching RAF Molesworth provides reunion with my elder brother I wish the names recorded on the inside cover of our father’s Nazi party diary be part of presentation to UK Police. I would then like to offer this item of Military Memorabilia to either yourself or Christiano Bath as means of fine payment to return to Brazil preferably with representatives of NASA and Disney.

To commence levelling the power of Rome held over South American’s, choice words from Mark Twain’s *A Connecticut Yankee in King Arthur’s Court* are provided in video *Jupiter Moon – Excalibur – part 3* and in dossier *Anunnaki Conquest B - Chapter 21 WW3 or Dagon’s Deal and Mark Twain*. It is with gratitude to employment with Connecticut aerospace firm Hamilton Sundstrand that archaeological discoveries were made.
