To Whom of Scotland It May Concern.

I believe you have been sending correspondence regarding debt collection to the address 10 Petersfield Villas, St Peter's Rd, Huntingdon, Cambs PE29 7YS where I resided for 3 months of 2021 and wish to inform you that I have been a temporary resident at Reef Surf Lodge, 32 Island Crescent, Newquay, Cornwall TR7 1DZ since November 2022 but due to rental increases am returning to residing in a small motorhome as of 29th April 2023.

I am assuming you provide service of consolidating a party's debt(s) and offer the service of negotiation in solving the problem of satisfying creditors demands and on occasion collection of asset(s) when finances are lacking by the indebted party.

Here is a list of whom I currently believe are in my pursuit as to money owed:-

- The Hong Kong and Shanghai Banking Corporation
- Office of the Mayor of London – Transport for London
- Catalyst Housing Association
- Anglian Water

Here is a summary as to how each debt was incurred:-

HSBC

During the period year 2000-2001 I was employed in Brazil as a Design Engineer by the American aerospace company Hamilton Sundstrand, a fairly lucrative salary provided Gold Visa Credit Card of limit £5,000. The New York 911 event resulted in termination of engineering contract in October 2001 and I embarked on marketing a product data management software trade-marked as CAD-Collaborate (a service for communicating engineering projects internationally) within the surfboard design and manufacturing industry of Ilha Santa Catarina, Brazil.

Experiencing onset of a limb paralysis disease in 2005 and having knowledge of Celtic sacred cartography, resulted in use of HSBC credit card to initiate a studios project in support of an archaeological expedition exploring the mountainous central region of Ilha Santa Catarina. Expedition success provided a wealth of artistic material which can be viewed via website www.apollobath.org and diversification of my career into the fields of banking and screenwriting.

Unfortunately my raising the issue of Brazilian laws pertaining to the country's national security in September 2010, which I was in fear of infringing if I continued to augment media projects, resulted in the Brazilian Federal Police selling my body to the Roman Catholic Church for medical experimentation. Consequence being long term injuries:- shrinkage of the brain; blurring of vision and problematic digestion.

I returned to the UK in March 2012 accompanied on the deportation flight by two Federal Police officers, one of their wives and a prison psychiatrist who all happily took a short holiday in the St George Hotel, Pimlico. I have been financially supported for the last 11 years by the UK's social services.

Office of the Mayor of London – Transport for London

Transport for London are claiming that I owe them £758 for driving along the A2 Rochester Way Relief Road on the 26/09/2018. This was due to seeking mechanical repair of my vehicle which I feared would breakdown if I continued journeying on the M2 motorway. In previous correspondence to Transport for London and their debt collection agency Marston Group I raised the issue of morality as my actions were in the best interest of road safety and not the advancement of Artificial Intelligence as endorsed by the then Prime Minister Theresa May. Catalyst Housing Association

February 2019 a missed work capability assessment with a doctor's office in Peterborough resulted in termination of Employment Support Allowance and housing benefit which had provided me with residence since October 2012 at 51 Ashton Gardens, Huntingdon, PE29 7HQ. This missed appointment was due to my showing commitment of a marriage proposal to a Venezuelan lady.

Acting in best interests of synchronising the effect of introducing the afore mentioned archaeological discoveries into the global economy, via safe haven banking venture 'Banco Atlantida', I exported vegetable seeds and dug a garden on Isla Margarita, Venezuela.

Ms Deena Coulsen of Catalyst Housing informing me to vacate the Huntingdon property on the 24th June 2019 to which I dutifully obliged, the circumstances as to my exiting this property are covered in letter 'Medina Catalyst False Debt Claim' link <https://apollobath.org/Debt%20Correspondence/Medina%20Catalyst%20False%20Debt%20Claim%201.pdf>.

Ms Coulsen also stated that I had not removed my possessions from the property, while waiting for Ms Coulsen's non arrival on the 24th June I took the following photographs:-



These three photographs show that I had left the property partially furnished and highlighted is the set of keys and thank you letter to Deena Coulsen left on the living room table. Proving that I had removed my personal possessions and returned property keys - contrary to statements later made by Ms Coulsen.

When requested to leave the property Deena Coulsen informed me that the property owner was wishing to sell and so assumed that on my departure the house would be cleaned and slightly renovated. On receiving demands of unpaid rent I called at the door of 51 Ashton Gardens and questioned the new resident as to when he had entered the property, the new tenant seemed to be a bit vacant minded and wasn't quite sure as to when he took up residence but it seems the property was vacant for about a year.

Among statements made by Ms Coulsen was one that seemed to be of a begrudging nature towards my having spent time in Venezuela. I wish to inform that scenes witnessed on Ilha Margarita are quite harrowing as to the lack of food. Many families who fled the country put their pet dogs into the street and I counted about 40 dogs slowly starving to death at the beach where they had congregated in hope of being fed food from the restaurants. However, business is at it's lowest and the street kids who befriended me are forced to feed on what few scraps they can scavenge from the garbage bins.

I hold ambition to return to Venezuela and continue gardening but have the problem of explaining to my friends the issue of an unscrupulous English landlord demanding cash for when I was living in a small motorhome parked in the street.

The videos are titled "The Whore of Babylon or Bob and Rocky - parts 1, 2 & 3" and "Emmanuel's Last Hot Supper".

"The Whore of Babylon or Bob and Rocky" was the final production made while resident at 51 Ashton Gardens and in June 2019 together with book 'The Mayan Prophecies' was gifted to MP for Huntingdon Jonathon Djangoly. Hoping that this introduction and subsequent ones to the Conservative Party would stimulate a positive response from the Tories, as yet I have received no acknowledgement from them.

On the 4th of October 2022 the BBC reported the death of the Lawyer Ian Hamilton KC, one of four students who broke into the Abbey.

"The stone had played a key role in the coronation of Scottish kings before being taken to London by King Edward I of England in 1296.

Mr Hamilton became a lawyer, and continued to campaign for independence.

First Minister Nicola Sturgeon described Mr Hamilton - who was 97 - as a "legend of the independence movement" and "one of the many giants on whose shoulders the modern SNP stands".

She added: "During my time as the SNP leader I have received occasional words of wisdom, encouragement and support from him, which I will always treasure."

On the 26th November 2022 the BBC reported death of Scotland International Rugby player Doddie Weir from Motor Neuron Disease but I am suspicious that Doddie may have experienced the same fate as my mother.



My mother Wendy Mary Parker - born in Malta 4th April 1942, died in Hinchingsbrooke Hospital, Huntingdon 31st November 2002 aged 59.

Following over 25 years employment in Hinchingsbrooke Hospital, my mother resident in Brampton village, began to experience paralysis of her left foot and ankle during September 2000, only nine months into her retirement. Throughout my mother's illness concern was that she was suffering from Motor Neuron Disease (MND). However, classic symptoms of MND are that facial muscles are affected and the patient is unable to smile, a classic case being Stephen Hawking who lived with MND for 55 years, symptoms my mother's condition didn't share.

My mother regularly saw consultant neurologists and even travelled to London to do so and for over two years no doctor was able to provide a diagnosis for her condition, as it slowly spread up from her ankle – consuming both her legs.

In the spring of 2002 my mother agreed to an experimental treatment consisting of transfusion of blood plasma. Her paralysis then crept up through the torso and she died from respiratory failure November 2002. Her condition only being diagnosed as Motor Neuron Disease **after** she had received the experimental treatment - having gone the previous two years undiagnosed.

While employed in the Aerospace industry of Brazil – August 2001, I travelled to Phoenix Arizona to meet Donald Byrn. Mr Byrn assisted by Mormon missionaries was providing a treatment for MND sufferers – an extract of peanut shell (Luteolin) to help repair the central nervous system. In the USA MND is called ALS (Amyotrophic Lateral Sclerosis), paralysed for over twenty years Mr Byrn had been in trouble with the ALS society of the USA – he told me in person his belief that he had got sick through drinking from a hosepipe on farmland.

On attending my Huntingdon School Reunion party in November 2016 it was sad to learn that two of my classmates, Kriston Pring and Victoria Evans with whom I had gone through both primary and secondary education, had recently lost their mother's to a paralysis disease.

At 29 Rutland Square, Edinburgh can be found offices to 'The My Name's Doddie Foundation' <https://www.mynamesdoddie.co.uk/> and I have intention in the very near future to visit Edinburgh where I was an Engineering Student 1992-93, hoping to make appointments with the SNP, Chinese Embassy and Doddie's Foundation.

I am also seeking support from the Scottish Rugby Union Team to air lift the 'Stone of Destiny' to Argentina for setting at Iguazu Falls – see Chapter 10. 'Iguazu Falls, a Terraforming Dome and the Grail Squadron' of dossier 'Establishing Embassy to Significant Religious Objects (SRO) Ark of the Covenant, Holy Grail & Caravan of Treasures – Grail Technologies' . <http://apollobath.org/docs/Part%203%20Grail%20Technologies.pdf>
