**Ref: Establishing Los Angeles Embassy to Significant Religious Object(s) – Family Matters**

This is my eighth presentation to the SNP (previous letters available at [www.apollobath.org/Letters of Introduction/Scottish National Party](http://www.apollobath.org/Letters of Introduction/Scottish National Party)). I wish to deliver this letter as an ultimatum to my brother Ian Parker and Aunt Coryn in that if they chose to continue follow **James Ronald Parker's** influencing path of cowardly denial, then on the 8<sup>th</sup> April I shall be reluctantly changing my name by deed poll from **Graeme James Parker** to **Graeme Sinclair Dollery** thus enabling me to cease regard my brother and aunt as kin folk.
